

RESOLUTION #11-17

A RESOLUTION OF THE BOROUGH OF CATASAUQUA, LEHIGH COUNTY, PENNSYLVANIA, REAFFIRMING ITS PRIOR APPROVAL OF THE ISSUANCE OF A PENNSYLVANIA ECONOMIC DEVELOPMENT LIQUOR LICENSE TO 129 HOWERTOWN ROAD, LLC t/a RICHIE’S PUBLIC HOUSE.

WHEREAS, by Resolution #9-16 the Council of the Borough of Catasauqua approved the issuance of a Pennsylvania Economic Development Liquor License, a copy of which is attached to this Resolution as Exhibit “A”; and

WHEREAS, the Borough was informed that the application for the liquor license was not submitted due to failings of his then attorney; and

WHEREAS, it is the intent of the Council of the Borough of Catasauqua to affirm its continued support of the application.

NOW, THEREFORE, it is resolved by the Council of the Borough of Catasauqua as follows:

1. Borough Council finds that the addition of a liquor license to the property known as 129-131 Howertown Road, Borough of Catasauqua, PA, tax parcel ID #640818543259 will have a positive impact on business and economic development in the Borough.
2. Borough Council finds that the issuance of a Pennsylvania Economic Development Liquor License is to the benefit of the community and the Borough’s economic development plans.
3. Borough Council understands and agrees that the issuance of a Pennsylvania Economic Development Liquor License is limited to the use and ownership at the single location described in the application to the Liquor Control Board, that location being 129-131 Howertown Road, Borough of Catasauqua, PA, Tax Parcel ID #640818543259 and the license being owned by 129 Howertown, LLC.
4. The Borough of Catasauqua has complied with the requirements of the Pennsylvania Code covering the issuance of an Economic Development Liquor License.
5. Borough Council hereby reaffirms its support the issuance of a Pennsylvania Economic Development Liquor License to 129 Howertown, LLC to be issued at the location noted as 129-131 Howertown Road, Borough of Catasauqua, Lehigh County, Pennsylvania.
6. Borough Council hereby resolves to support the issuance of a Pennsylvania Economic Development Liquor License to 129 Howertown, LLC to be issued at the location noted as 129-131 Howertown Road, Borough of Catasauqua, Lehigh County, Pennsylvania.
7. The intent of this Resolution is to reaffirm the action taken by Borough Council pursuant to Resolution #9-16, a copy of which is attached here as Exhibit “A”.
