ISSUED PURSUANT TO BOROUGH ORDINANCE NO. 922

GENERAL INFORMATION

Extracted from Ordinance No. 922

SECTION 6 – LOCATION: IT SHALL BE UNLAWFUL FOR ANYONE TO HOLD A GARAGE/YARD SALE ON PROPERTY OTHER THAN THEIR OWN RESIDENTIAL LOT.

SECTION 7 – HOURS: NO GARAGE/YARD SALE SHALL BE CONDUCTED BETWEEN THE HOURS OF 8:00 PM AND 9:00 AM.

SECTION 8 – ENCROACHMENT ON RIGHT-OF-WAY:

1) NO GARAGE/YARD SALE SHALL ENCROACH ON PUBLIC RIGHT-OF-WAY, SIDEWALK, STREET OR ALLEY.

2) AT ALL TIMES, THE APPLICANT SHALL BE RESPONSIBLE FOR THE MAINTENANCE OF GOOD ORDER AND DECORUM ON THE PREMISES DURING THE HOURS OF SUCH SALE OR ACTIVITY AND SHALL BE RESPONSIBLE FOR REMOVING DEBRIS, GARBAGE AND LITTER FROM THE PREMISES AND FROM SURROUNDING PUBLIC PLACES FOLLOWING THE SALE.

SECTION 9 – SIGNS: EACH PARTY SHALL BE ALLOWED TO PLACE A SIGN NO LARGER THAN 2' X 2' ON THEIR RESIDENTIAL PROPERTY TO IDENTIFY THE GARAGE/YARD SALE. SUCH SIGNS SHALL NOT BE PLACED UPON THE PROPERTY PRIOR TO 24 HOURS BEFORE THE SALE AND SAID SIGN MUST BE REMOVED FROM SAID PROPERTY WITHIN 24 HOURS AFTER THE SALE.

SECTION 10 – ENFORCEMENT: THIS ORDINANCE SHALL BE ENFORCED BY THE POLICE DEPARTMENT. IT SHALL BE THE DUTY OF THE POLICE DEPARTMENT TO INVESTIGATE ANY VIOLATION OF THIS ORDINANCE.

SECTION 11 – PENALTIES: ANY PERSON VIOLATING ANY PROVISIONS OF THIS ORDINANCE SHALL, UPON CONVICTION THEREOF, BE SENTENCED TO PAY A FINE NOT TO EXCEED \$300.00 AND/OR NINETY (90) DAYS IN JAIL.
