

RESOLUTION #18-17

A RESOLUTION AMENDING THE SCHEDULE OF FEES & CHARGES, DATED DECEMBER 14, 2016, REVISING THE WATER RATES AND SEWER RATES.

WHEREAS, Borough Council wishes to revise the Water Rates and Sewer Rates.

BE IT RESOLVED by the Council of the Borough of Catasauqua, County of Lehigh and Commonwealth of Pennsylvania:

SECTION 1: That the quarterly charges for the metered usage of the water system, effective for usage billed on or after April 1, 2018 shall be:

Minimum Charge (First 5,000 Gallons per Quarter) FOR THE FIRST UNIT:

Meters Less than 1"	\$24.75/Unit
First Unit for Meters 1" or Larger	
1"	\$49.50/Unit
1½"	\$99.00/Unit
2"	\$ 173.50/Unit
2½"	\$ 272.25/Unit
3"	\$ 371.25/Unit
4"	\$ 618.75/Unit
6"	\$1,237.50/Unit
8" and Larger	\$1,980.00/Unit

Minimum Charge (First 5,000 Gallons per Quarter) EACH ADDITIONAL UNIT: \$24.75/Unit

Every 1,000 gallons thereafter: \$4.38 per thousand gallons.

SECTION 2: That the Quarterly charges for the metered usage of the Water System, effective for usage billed on or after January 1, 2019 shall be:

Minimum Charge (First 5,000 Gallons per Quarter) FOR THE FIRST UNIT:

Meters Less than 1"	\$25.50/Unit
First Unit for Meters 1" or Larger	
1"	\$51.00/Unit
1½"	\$ 102.00/Unit
2"	\$ 178.50/Unit
2½"	\$ 280.50/Unit
3"	\$ 382.50/Unit
4"	\$ 637.50/Unit
6"	\$1,275.00/Unit
8" and Larger	\$2,040.00/Unit

Minimum Charge (First 5,000 Gallons per Quarter) EACH ADDITIONAL UNIT: \$25.50/Unit

Every 1,000 gallons thereafter: \$4.52 per thousand gallons.

SECTION 3: That the Quarterly charge for the metered usage of the Sewer System, effective for usage billed on or after April 1, 2018 shall be \$41.20 per unit (minimum charge):

Every 1,000 gallons thereafter - \$6.45 per thousand gallons.

SECTION 4: That the Quarterly charge for the metered usage of the Sewer System, effective for usage billed on or after January 1, 2019 shall be:

- A. Meter Rates: First 5,000 gallons per quarter - \$42.45
Every 1,000 gallons thereafter - \$6.65 per 1,000 gallons.

SECTION 5: That all other fees and charges not herein modified shall remain the same, and the Schedule of Fees and Charges dated December 20, 2017 is hereby adopted.
